- Lower educational attainment was more likely for children whose parent’s divorce was less likely.
- Children’s reactions to parental divorce vary.
- The likelihood of risky behaviors is higher for children who have experienced parental divorce.

Conclusions

- This literature review concluded that parental divorce may have an affect on a child’s educational attainment and when that is compromised, the likelihood of succeeding in college decreases.
